1.8. Character / Psychological Analysis

He seems to be very intelligent, also possess good organizational skills. In spite of the fact that he is involved in organized crime and connecting in murders throughout KOSOVO, there is no evidence or warrants against him.

As many UCK members, HALITI espoused Marxist ideology during the early 1990's.

2. BACKGROUND

2.1. Military / UCK / KPC Background

He was Chief of Finance and head of the logistics directorate of UCK General Staff.

05 APR 00: Rumors indicate that he has collaborated with the UDB (Serb Intelligence Service). Informed the Serbs of arms 'shipments' destined for the FARK (that were close to Mr. RUGOVA), which had a strong struggle with UCK.

2.2. Political Background

He was connected to the increased intimidation of LDK members through the KSHIK.

He is a Member of the PPDK Presidency and one of the Albanian Representatives in the Transitional Council.

He is PDK leader advisor, member of PDK Presidency and known as the blackmail coordinator. He has been an identified as being active supporter of the Workers Party of Albania, in KOSOVO.

He is the power behind Hasim THAQI controlling the PDK politician through financial means

2.3. Police / KPS Background

2.4. Business/Economic Interests/Ownership Background

He is rumored to be a Multi-Millionaire. The Homeland Calling fund, which was more or less ran by Xhavit HALITI, is where his wealth appears to stem from; there have been numerous rumors suggesting that the funds coffers were porous and would end up in the pockets of HALITI has strong ties to the Albanian Mafia.

The Homeland calling fund received its money from Kosovars that lived abroad, and those supporting the UCK cause. After the war stopped the money coming in for this cause slowed down. As a result, HALITI turned to organized crime on a grand scale. Using this money he supports the PDK and possibly the K-SHIK.

2.5. Criminal Background (Known and/or Suspected Criminal Activities)

Highly involved in prostitution, weapons and drugs smuggling also petrol smuggling; linked in weapons smuggling to Fatos NANO. He has good relation ship with ELSHANI family and he controls crime and smuggling activities in VITOMIRICA (DN 4526) which is a geographically strategic junction for his smuggling business avoid the LULINA Pass control.

He is possibly involved in the murder of Xhemajli MUSTAFA, LDK and former advisor of Mr RUGOVA, killed on 07DEC00. HALITI probably ordered Fatmir DURMAKO to kill Mr MUSTAFA. He has also been linked to at two deaths, the death of Ilri KUNOSHETI in 1998 and the death of Ali UKA in 1997. Ilir produced a six-page report of illegal activities that Xhavit had committed.

Has been arrested for possession of drugs and 500,000 DM.

2.6. Family Background (Family Member; Clan Member)

In the late 1980s: He immigrated to Switzerland. He is believed to have family in Switzerland and in Tirana (ALBANIA).

(Brother-in-law of RUGOVA) - NOT CONFIRMED

2.7. Others

HALITI was 'placed' by the Serbs in a prison cell with Adem DEMACI. The two shared a cell for four years, and HALITI became a confidant of DEMACI.

He is reported to be the responsible for the operation of the "ARCO BALENO" ambulance, intercepted in NOVO SELO (weapons smuggling in emergency car).

4. OTHERS COMMENTS

Xhavit HALITI with Fatos NANO (former Prime Minister of ALBANIA) were in charge of destabilizing area before the KOSOVO conflict started and they are supporters of GREATER ALBANIA. HALITI has probably a strong support from ALBANIA to due his links with the ShiK, his illegal activities and his relations with Fatos NANO.

Mr HALITI has been political and financial advisor of Hashim THACI. He is responsible for the budget of PDK and of the association named "Call of the MOTHERLAND". The organization controls the money of the Albanians who are spread out in the world and are willing to help the Albanian cause. There are some rumours that THACI would like distance himself from HALITI (bad reputation amongst K-Albanians), but he cannot because HALITI of the control HALITI has over Hashim THACI. Several reports state that HALITI is more than the 'eminence grise', and HALITI should be the real boss.

He is probably behind the suspension of Remi MUSTAFA and other four KPC members, that suspensions were politically motivated because all of them were Ramush HARADINAJ supporters (AAK).

Mr HALITI with Kadri "SALI" VESELI, chief of KshiK prepared a "Black list" of moderate politicians who were intimidated by KShIK and PDK supporters.

Mr HALITI was coordinator of extortion operations for PDK support. He is reportedly related to the MUSAJ family and he probably passed them information that Daut HARADINAJ is behind the 19 July 00 killing one of the Sadik MUSAJ's brother.

For his business activities HALITI is using the PRISTINA "Grand Hotel" as his base.

European Council has drafted a list where are included the Albanians' names who are not accepted to enter its party members. **Xhavit Haliti**, Kosovo Democratic Prosperity Party (PDK), National Liberation Army (NLA), supporter, born on 08.03.1956 is one of the names in the list mention before (EU doc 19 Jul 01).

(S// REL TO USA AND NATO) Xhavit has been linked to two deaths:

- Ilir Konuschevki, a contender for leadership with Haliti for the Lafi Zone in 1998. Documents
 were brought forward by Ilir that proved Haliti was involved in crime. This led to Haliti being
 expelled from the KLA and Ilir was found, less than a month later, dead by the Kosovo border.
- Ali Uka, a reporter in Tirana, who supported the Independence movement but criticized it in print. Uka was brutally disfigured with a bottle and screwdriver in 1997. His roommate at the time was Hashim Thaci.

Xhavit HALITI now has an additional bodyguard called Fadil SNU. Fadil SNU is a close associate of Agron HARADINAJ and can often be seen in his company. Fadil SNU is often seen at the ShIK offices and is described as follows:

(1). Age - Approximately 35 years old.

(2). Build - Athletic.

(3). Complexion - Dark, swarthy.(4). Distinguishing Marks - None identified.

(5). Elevation - Approximately 168-170 cm.

(6). Face - Clean shaven.

(7). Hair - Black and brushed back.

CONTACT COMMENT: I am sure that Fadil [SNU] is a member of ShIK. I believe he worked as a bodyguard within the criminal fraternity about 2 ½ years ago. I believe he is from PRISTINA (EN 1323), and still lives there at the moment. Rifat CEKU now appears to be concentrating on matters within the Grand Hotel and only driving HALITI when required, whilst Fadil SNU is concentrating on HALITI's security. COMMENT ENDS. (Answer RFI 326)

There is a great respect around him, and the fact that he probably is the main figure in PDK is not making this impression less.

He is a hard-liner, people are afraid to pass information about him because they know he can buy information from just about anyone.

5. ASSOCIATED PERSONALITIES

5.1. Business

The **ELSHANI** family has close links with Xhavit HALITI who allegedly is connected to organized crime as well as K-ShIK. This is interesting since HALITI has been linked to intimidation and murder of LDK members and is himself involved in PDK. Through the head of the ELSHANI family there is a close connection to Ekrem LLUKA, a wealthy businessman frequently associated with organised crime, mainly smuggling.

Agim ELSHANI: the beer factory director (Ekrem LLUKA owns the factory), is closely connected to HALITI

5.2. Crime

Fatos NANO: former Prime Minister of ALBANIA and involved in weapon smuggling with HALITI Bujar BUKOSHI: they have co-operated in a joint venture to set up a bank in Pristina (this venture was unsuccessful).

Sabit GECI (aka Copa or "the lame"): Sabit GECI and his brothers were probably Mr HALITI'S men of all works. during the war "COPA" was one of the leaders of the PU (the UCK security service). He is one of the main persons involved in organized crime in PRISTINA. GECI group was reportedly linked to Xhavit HALITI and Rexhep SELIMI and to Special Police during the Kosovo war.

Shaban SHALA.

Ekrem LLUKA, a very prominent criminal figure. They are connected through Agim Elshani, who manages Lluka's legal beer factory(The Elshani family, five brothers, are all connected to Haliti and are suspected of illegal trafficking.

HASKAJ, a former sniper and reputed to be a paid assassin, who charges between 10,000 and 20,000 DM per attack. Haliti has been spotted in Haskaj company with Hashim Thaci.

Naim MUJA, a Pristina based arms dealer. Haliti sent Muja to Albania to be Ahmet Krasniqi's bodyguard shortly before Krasniqi's assasination in SEP 98

Nexmija HOXHA and **Hyshini MILOSHI**, active supporters of the Workers Party of Albania in Kosovo. Hyshini is believed to be part of an unidentified crime group

Daut HARADINAJ, thought to be connected to crime in Western Kosovo.. Daut is on trial for criminal activity at this time.

5.3. Politics

Hashim THACI: Leader of PDK.

Adem DEMACI: They shared a cell for 4 years and HALITI became a confidant of DEMACI. DEMACI is advisor of Prime Minister in KOSOVO and Chairman of the Committee for Tolerance, former UCK political leader.

Rexhep SELIMI: He was a UCK member in the Drenica and then public order minister within the PGOK. Rexhep has been blacklisted by the US government.

Ramush HARADINAJ is President of the AAK and is working on his image and may be moving away from that connection.

Xhavit HALITI was proposed in late Jan 02 along with Hydajet HYSENI-KALOSHI as the PDK's nominations for the their two positions on the Assembly Presidency. On 04 Mar 02 HALITI's nomination was duly approved by an Assembly vote. HALITI is also on the Committee of Emergency Preparedness (a hang out for those with connections to either AIK (Agim KRASNIQI (LDK)) or KShiK (HALITI himself)), and the Vice-Chairman of the Budget Committee.

HALITI's involvement in the Assembly was initially limited, however he has become a regular speaker and has expressed his views quite often. For instance in the debate on Privatization he expressed his frustration that the Assembly was wasting it's time on a debate about which they little real influence on whilst neglecting issues that they could manipulate to the benefit of the people of KOSOVO. HALITI suggested altering the Constitutional Framework if the Assembly wanted to discuss other issues. HALITI, who is a wealthy man from his time in exile in Switzerland, is almost certainly very interested in the process of privatization and the establishment of the KOSOVO Trust Agency (KTA) with an eye on potential investment opportunities.

Equally, due to visits abroad, the Assembly Presidency enjoys a reasonably good working relationship and there have been several occasions where there have been exchanges of banter between HALITI and Nexhat DACI (Assembly President). (update 01.01.-01.09.2002)

HALITI SUPPORTS BUJAR BUKOSHI AND HIS NEW PARTY (PReK)

HALITI has also expressed support for Bujar BUKOSHI in his venture of forming the New Party of Kosovo (PReK). BUKOSHI and HALITI know each other well as both were involved in raising money from the Diaspora in order to fund activity in Kosovo (including KLA). It appears that rather than competing against each other, there was some co-operation. Furthermore, HALITI's expression of support could be due to the PDK hoping that PReK may steal votes from the LDK. (update 01.01.-01.09.2002)

5.4. Military / Security

Fatos KLOSI: He is the ShIK commander in Albania. Haliti was his body guard and his associate before the conflict in Kosovo.

Kadri "SALI" VESELI who former PU commander in Pristina. He is the ShIK commander in Kosovo.

Rifat CEKU: has been seen several times in company with HALITI, and together they controlled the suspension of, among others, Rrustem MUSTAFA.

Azem SYLA (aka Daja): they both are close together since many years (as LDK members). They both are accused of having taken control of the UCK with other DRENICA clannish members during the war, thus preventing the LDK and other factions of influencing the HQs and of claiming paternity of the UCK. Moreover both men managed to control all re supplying circuits from Albania

to the UCK, thanks to a tight connection with the ShIK and the mafias. They also diverted weapons and money for their own profit that were initially to be transferred to KOSOVO.

Sami LUSHTAKU: His family is one of the most influential in the region and since the end of the JASHARIS the LUSHTAKU have narrow links with the SELEMI family.

Sulejman SELIMI (aka Sultan), former KLA member and possible criminal figure : Rexhep's brother. Syljeman is Deputy Commander of the TMK.

Isa BALAJ is linked to KShIK and Mr. Xhavit HALITI.

Agron HARADINAJ is believed to be a member of K-ShIK and a close associate of Xhavit HALITI, Isa BALAJ, Ali HASKAJ and Azem SYLA.

Ali AHMETI aka Abaz XHUKA, Hashim THACI, Azem SYLA and Xhavit HALITI, the four founders so-called 'founding fathers' of the UCK in 1993.

5.5. Others

FOES:

- Rrustem MUSTAFA: HALITI was probably behind his suspension from KPC
- Ramush HARADINAJ: leader of AAK the opposite party to PDK.
- Hashim THACI: there are rumors that there is an internal dispute between HALITI and THACI.
- Driton ZHJEQI a feud -- different fractions within UCK. Involved in getting ZHJEQI in ALBANIAN prison?
- Is on the EU entry-ban list

He is also involved in the FENIKS Co. This company which is based in Switzerland is led by Quazim OSMONAJ, with Nazim HARADINAJ who is a very close business friend of HALITI. FENIKS has very close relation with the Islamic Jihad and the Turkish Islamic extremists. (J2X HUMINT SUMMARY – 06 OCT 00).

THE ALBANIAN CONNECTION:

HALITI has served as the Provisional Government's representative to Albania, but has spent most of his time in Pristina with only occasional trips to Tirana since June 1999. He has longstanding ties to Albania through his wartime role as Kosovo Liberation Army (UCK) logistics chief, in which he was responsible for funnelling weapons and money through Albania to UCK units in Kosovo.

MILITARY CONNECTION:

As described above, HALITI held a position in the UCK General Staff. In this position he has built up close connections with Rustem "REMI" MUSTAFA, Ramush HARADINAJ, Rexhep SELIMI, and Latif GASHI.

GASHI is the Chief of Intelligence in the RTG 5 (Former Llap operational zone). This link is very useful for his close ties to Selimi, both in the official PRP business and the suspected criminal activities.

Reportedly, REMI and HARADINAJ tended to oppose Hashim THAQI. It was HALITI who acted as an intermediate between those two and THAQI. His close tie with both HARADINAJ and REMI provides HALITI with a secure ground for his criminal activity. These two zone commanders control about 60% of Kosovo proper. HARADINAJ is connected with Ekrem LLUKA who is involved in smuggling, mostly working from the PEC area.

The following is a part of J2X Drenica area 110302.doc GECI family

(NS Rel Aut Fin Swe) The **GECI** clan is very active in PEC, MITROVICA, SKENDERAJ and PRISTINA areas. Its principal illegal activity is the smuggling of petrol through the KULINA pass.

For this special activity, the GECI family which is native of SRBICA/SKENDERAJ area, has the pledge of Xhavit HALITI, who is the "PATRON" of all the goods passing through VITOMIRICA towards KULINA and MONTENEGRO. The economical power, the good relationships with "ZEKA" HALITI and the friendship with the SELIMI clan ("Sultan" Sylejman, Rexhep and Ilaz from KLINA) gives to the GECI Family the role of the Drenica Valley criminal leading group.


(NS Rel Aut Fin Swe) ISTOK is the strategic epicentre of all the illegal traffics that travel through Western Kosovo. As a matter of fact, its position at the junction with the route approaching to the MONTENEGRO borders, Drenica Valley and KOSOVSKA MITROVICA areas, makes the town a target spot for the interests of some of the most powerful criminals of KOSOVO. The town, politically similar to KLINA, is considered a TMK protectorate. Xhavit HALITI, Sylejman SELIMI and GECI gang delegate the control to the local KPC Detachment COS Najm XHURAJ.

Criminal control in Pec area DOI 09/08/02

The most important town in western KOSOVO, at the arrival of the liberators (R. HARADINAJ), was immediately put under the control of a self-appointed municipal government composed of several non professional politicians led by Ethem CEKU, who was able to arrange a convenient agreement among the local powerful criminal masterminds, his personal interests and Ramush HARADINAJ will to rise to political power. Since then the criminal scene has been dominated by two prominent figures:

<u>Xhavit HALITI</u>, who exercises control on the major criminal bands of the PEC area such as: KELMENDI Family and MURIQI clan, relying on the favour of the local low-level criminal activities mainly exploited by FERIZI gang:

<u>Ekrem LLUKA</u>, who has directed his attention towards the control of the local Municipality Departments especially towards those who have the strategic monopoly of public funds. In brief, the lucrative LLUKA empire has been achieved through the use of the corruption scheme which seemed to have affected large part of the community, even indirectly the local UNMIK adm.





The LDK Information Service has long suspected DURMAKO of being a KShIK operative. FHT COMMENT: The individual pieces of information are assessed as B2, however, the conspiratorial theme of the report and analysis by the LDK is impossible to verify. The events may be unrelated and merely coincidental, but bear reporting together in light of recent events. COMMENT ENDS. J2X COMMENT: A MNB-E report (C3) in the J2X Summary of 07 Dec 00 stated that the LDK Information Service believes that the person who killed MUSTAFA was Fatmir DURMAKO. The LDK security officials had previously identified DURMAKO as a member of the GNJILANE KShIK. The report also stated that they suspected him of being a double agent for the Serb State Security Service. LDK information officers from PRISTINA spotted DURMAKO in the city but he now rarely goes out at all, maintaining a low profile. The LDK information office only has circumstantial evidence pertaining to DURMAKO's connection to the crime, however, they are convinced he is the man who assassinated MUSTAFA. Because DURMAKO has been a KShIK operative and has connections to the PDK, the crime is viewed as a politically motivated killing. The LDK believes that the PDK's intelligence apparatus identified DURMAKO as a former Serb collaborator and coerced him into this activity. DURMAKO, under threat of death, and possibly to clear his name, killed MUSTAFA. This appears to be corroborated by a MNB-C contact who reported that a member of ShIK, Fatmir DERMAKU (sic), may have carried out the killing of

HALITI can also rely on the financial support of the "American Albanian Civil League", which is the American Albanian emigrants agency for the support of the "Greater Albanian" project in the USA. HALITI has been reported as the "trait d'union" between the MILOSEVIC regime and the Albanian, Fatos NANO, for all the financial transactions and financial movements which, starting from BELGRADE (DQ 6064), are currently going to ATHENS and later on to PRISTINA (EN 1223) via TIRANA. Part of this financial flow comes directly from MILOSEVIC, but another part of it comes from CYPRUS, where "SLOBO" has several secret bank accounts. HALITI is also involved in the FENIKS Co.
